

Directions to Penn College

From the North: From U.S. Routes 14 and 15 South, follow U.S. Route 15 South to Williamsport and Maynard Street Exit.

From the South: Follow U.S. Route 15 North to Williamsport and the Maynard Street Exit.

From the East: Follow Interstate 80 to Interstate 180/Route 220 (Exit 212B). Continue on Interstate 180/Route 220 to Williamsport and the Maynard Street Exit.

From the West: Follow Interstate 80 to Route 220 (Exit 178). Follow Route 220 to Williamsport and the Maynard Street Exit.

All Traffic: From the Maynard Street Exit, travel North on Maynard Street to Penn College entrance on left.

Directions to the PDC and Parking

From the Main Entrance, continue straight on Hagan Way. The PDC will be on your left, just past the Victorian House. A limited number of parking spaces will be available here.

Continue straight for additional parking in various main lots. Do not park in spots marked Reserved or Maintenance Only.

**“Sustainable and Green @ your library:
Greener and Eco-Friendly Libraries in the New Century”**

Frederick Stoss will discuss the history of the library “green” movement and provide an introduction to environmentally friendly services, programs, projects, and opportunities for librarians.

Stoss is the Biological and Environmental Sciences and Mathematics Librarian in the Arts and Sciences Libraries’ Science and Engineering Library at the SUNY University at Buffalo. He is the current Chair of the ALA Task Force on the Environment and is the creator and moderator of the ALA Green Libraries Community of ALA Connect.

“Weatherization and the Environment”

Through the growing demand for service fueled by the American Recovery and Reinvestment Act (ARRA), the Weatherization Training Center (WTC) expects to train up to 1,000 men and women in the coming year. The funding boost is expected to provide 940 jobs in Pennsylvania over the next three years for individuals who will weatherize at least 29,700 more housing units, reducing energy usage in the state by the equivalent of 155,000 barrels of oil a year.

John Manz serves as Director at the Weatherization Training Center (WTC) at Pennsylvania College of Technology, Williamsport, PA. He is a state-certified weatherization instructor and holds Universal EPA certification. The WTC has been the state’s primary resource for weatherization-related technical education and training since 1985.

Megan Epler will discuss energy assessments and strategic energy management to conserve energy and save money. She will also introduce Act 129, legislation that mandates the largest electric utilities in the State to reduce their baseload consumption, PPL’s Energy Efficiency & Conservation Programs, and Electric Choice.

Megan Epler is an Energy Specialist in SEDA-COG’s Energy Resource Center, Lewisburg, PA. Epler provides energy reduction technical assistance to businesses, local governments, non-profit organizations and schools. The Energy Resource Center (ERC) promotes and facilitates the adoption and expansion of efficient and renewable energy technologies and expertise throughout SEDA-COG’s 11 county region.

Learn how an 1814 building became more energy efficient and saved money through an energy audit.

Wunderly is Pennsylvania Room Supervisor and Curator at the Centre County Library and Historical Museum, Bellefonte, PA.

This Workshop will bring an increased awareness of green issues, policies, and initiatives. Librarians and staff will learn how to incorporate energy efficiency and conservation into libraries and the communities they serve.

Public librarians can share this information with trustees to develop conservation plans. Spending less on utilities leaves more for materials, programs, and staff.

Academic and school librarians can share this content with professors and teachers to improve academic achievement among students. Energy efficiency in schools, colleges, and universities translates into more money for materials to support Pennsylvania academic standards.
